III International Congress on Drowning Prevention (CIPREA)

"Today's prevention is tomorrow's safety"

Córdoba, Spain – October 15, 16 and 17, 2021

This Congress is an educational event and a reference on the calendar of the Royal Spanish Lifesaving Federation. It is a biennial opportunity to bring together the main experts, research, systems and information on on drowning prevention, rescue, lifesaving, water safety and lifesaving sport.

The third edition of CIPREA, in Córdoba (Spain), also gives us the opportunity to report on the progress in the response to avoid drowning.

For this reason, the Federation is requesting abstracts from possible researchers and experts in each one of the nine thematic areas. These themes reflect the challenges to reduce drowning at the regional, national and global levels.

The themes are:

- Prevention
- Data
- Swimming and Water Safety Education
- Rescue
- Medical
- Disaster and Impacts of Climate Change
- Migrants and Refugees
- Innovations
- Sport

Organization of the Congress encourages consideration of cross-cutting issues within the themes that comprise the current understanding of research and practice.

Rules for the presentation of oral communications and posters

The papers submitted should be related to the different thematic areas of the program, and may contain various topics and refer to studies or theoretical proposals, as well as to practical experiences, since given the technical-professional nature that Congress also possesses, those experiences and intervention works eminently practical that are of interest, within the themes exposed in the congress.

At least one of the authors must be registered in the congress and no more than 2 papers signed by the same principal author will be accepted.

Of all the proposals received, Scientific Committee will select those works that stand out for their quality, interest or applicability and innovation or relevance in this professional field, for presentation at the time and place established for it, and that will be well in oral presentation format or in poster format, according to the consideration of the Committee.

For your consideration, the participants will have to send in a first moment and for their evaluation, an abstract, corresponding to a theme (no more than 300 words) in Spanish or English, that reflects the most important aspects of the research. All abstracts should include: introduction, method, results, discussion, conclusions and / or practical applications and references.

Moreover, abstracts accepted to be presented at the congress, regardless of the format (poster or oral presentation), that meet the publication conditions and receive the approval of the Scientific Committee will have a participation certificate and will be eligible for special recognition through a certificate accredited to the best communication and the best poster.
